At just 17 years old, Sam's passion for computers and a heart for community led him to want to begin a Not-For-Profit organisation. Eager to find a solution for repairable tech, the environmental impact of E-waste, and to create accessible technology for all Sam's Spares was born. From a very young age, Sam was surrounded by computers and technology; with his extended family being in the industry, a natural love for all things tech emerged.

Sam aimed to create an organisation that could be the step between the user and the recycler, allowing technology that could be repaired or reused another lease on life. Sam's core values keep his focus on companies moving to sustainable technology practices and allowing a right to repair.

Sam's passion is repairing technology; Sam hopes over time, many other roles he is doing will be able to be passed on, and he can focus on training and repairs. Sam divides his time between Sam's Spares and his own private Support Work business, offering one on one motoring/tutoring to other Autistic youth, upskilling and training them to follow their passion.

	Chair David Morrison presented his report highlighting:	
	 2022-2023 was an extremely productive and successful year; The past year has underscored an unwavering commitment to learning from and building the capacity of our 791 valued member organisations across Western Australia; Delivered programs across many sectors and regions, in extensive collaboration with community, government and corporate stakeholders, to reach new volunteers and maximise the quality and impact of existing volunteer programs; The new National Strategy on Volunteering focused on improving the volunteer experience and creating the conditions for volunteering to thrive; VWA continued to invest in volunteer management training, expanded our leading corporate volunteering program, and were proud to launch our new IT product Involve, which has already begun to revolutionise volunteer coordination; VWA responded to the call for more young volunteers by demonstrating the curriculum links achieved by student volunteering; David thanked VWA's hardworking staff and dedicated Board, as well as supportive partners and committed members, all who share VWA's vision of 'a society in which everyone is inspired to make a difference'.

	 Tina thanked Sam for sharing his volunteering story and congratulated him on being a finalist for the Humanitarian of the Year Awards; Tina acknowledged the warm and poignant Acknowledgement of Country by Sharon Wood-Kenney;
	Tina presented the CEO Report with the following highlights:
	 This year has been one of collaboration, growth, and community impact, reflecting VWA's strong commitment to embracing change and strengthening volunteering; VWA continued to be a passionate advocate for volunteer-friendly policies and practice, engaging with policy makers on a range of issues; Proud to extend our reach and partner with other organisations through the Volunteer Management Activity program in delivering innovative solutions to encourage volunteering in underrepresented cohorts so they can access the benefits and meaningful experiences afforded by volunteering; Provided extensive one-on-one support to hundreds of volunteer managers, placed over 3000 corporate volunteers into the community, launched Involve to address volunteer management IT challenges; Farewelled the Hon Stephen Dawson MLC due to a portfolio change, and welcomed the new Minister for Volunteering, the Hon Don Punch MLA - thanking them both for their contributions through the Volunteering Community Reference Group; Tina expressed sincere thanks to the Volunteering WA team, committed Board members and loyal volunteers for their tireless, industrious enthusiasm.

9	Report from the Treasurer – Libby Hewton
	Libby Hewton presented the financial report for the year ended 30 June 2023. Key highlights were as follows:
	- Volunteering WA has sustained a strong financial position through

- Volunteering WA has sustained a strong financial position through careful management of resources to ensure ongoing financial viability;
- Diverse income streams from a range of corporate partners, not-for-profit clients, member volunteer involving organisations, and government departments have been maintained and grown over the year through a rich variety of programs and services offered;

- Total revenue has reduced slightly this year as some projects for the development of IT systems and other one-off initiatives were finalised;
- The Corporate Volunteering program has continued to expand with existing and additional corporate partners, supporting nearly 80 not-for-profit organisations based in Perth and the regions across a variety of sectors;
- Expenditure has increased with direct program costs and outgoing grants to WA volunteer involving organisations representing 35% of total costs;
- A conservative decision has been taken to fully expense the previously capitalised value of IT development costs in this financial year;
- This represents a one-off, extraordinary expense of \$478,500 recognised in the profit and loss;
- Volunteering WA has chosen to fully expense the IT development costs as opposed to amortising the cost over the useful life of the asset which has resulted in a reported deficit of \$331,601, making note that this is not a reflection of the healthy operating position and financial strength of the organisation;
