## Training (free and fee-based advanced training):

## 'On-demand' or 'customised' off-site training:

Our standard or customised courses can be delivered at a time suitable to your organisation's needs and off-site for the following fees:

- For financial members – half day session: from \$660 inc. GST (non-financial from \$990)
- For financial members – full day session: from \$1,100 inc. GST (non-financial from \$1,540)
- For corporate/government sector – full day session: from \$150 inc. GST per attendee

## Volunteer Information Records Administrator (VIRA):

VIRA is a user-friendly volunteer management tool that allows volunteer involving organisations to record and report volunteers' details, contribution in hours, services provided, recognition, reimbursement and training undertaken. The annual fee listed below will be invoiced each year.

Financial members:

- \$110 inc. GST per annum for members with 0 to 50 volunteers
- \$220 inc. GST per annum for members with 51 to 100 volunteers
- \$330 inc. GST per annum for members with 101 to 250 volunteers
- \$660 inc. GST per annum for members with 251 to 500 volunteers
- \$880 inc. GST per annum for members with 501 to 1000 volunteers
- \$1650 inc. GST per annum for members with 1001 to 2000 volunteers
- \$2200 inc. GST per annum for members with 2001 to 5000 volunteers
- \$3300 inc. GST per annum for members with 5000+ volunteers
