The Chair welcomed new member Phil Scanlan to his first meeting.











1. Presentation on volunteering experience by founder of Activate Mental Health

VCRG member Rahul Seth gave a presentation about his volunteering experience founding Activate Mental Health, a not for profit which enables people to take action to improve their well-being through running and participating in fun, social events. Last year with only a \$5000 budget Activate Mental Health held 399 events which reached 2948 people. Rahul's presentation emphasized the importance of a diverse skill set, networking, teamwork and outcomes measurement when founding a small Volunteer involving Organisation.

2. Update on Volunteering WA State Election Priorities 2025

Tina Williams explained VWA have promoted the VWA State Election Platform to leaders of all the WA political parties. Party leaders have been asked to confirm their support for VWA priorities for publication in a VWA election scorecard format.

3. Removing Barriers to Volunteering: Facilitating Participation for Seniors and Financially Disadvantaged Individuals

VCRG Members discussed the issues surrounding existing volunteer screening processes arising from deidentified case studies from five volunteer involving organisations and their volunteers. These included the requirements of older and financially disadvantaged volunteers. Recommendations to Communities based on the VCRG discussion and findings will be circulated by VWA out of session for endorsement by the VCRG prior to the May meeting.

4. Update on Cross Government work to streamline volunteer checks including new online form for Working with Children Check

Angelo Barbaro Exec. Director Regulation & Quality, Communities, spoke about the current government project to streamline volunteer checks commencing with the Working with Children Check. The new process will leverage work being done on the WA government's digital ID.

The VCRG emphasised the need for consultation and testing by Volunteer involving Organisations in the development of new systems and processes. Angelo also advised that public consultations will be held on the upcoming review of the Working with Children Legislation are planned for mid-2025.

5. National Child Safe Principles and Volunteer Involving Organisations.

Phillipa Wenn, A/Principal Policy Officer, Royal Commission into Institutional Responses to Child Sexual Abuse Implementation Team gave a presentation about the resources available for Volunteering Involving Organisations to implement the principles which have come out of the Royal Commission into Institutional Responses to Child Sexual Abuse.
