#### Communique #6

The Chair welcomed Hon. Stephen Dawson MLC, Minister for Volunteering and all members of the Group.

As the new Minister for the portfolio, Minister Dawson thanked the VCRG for their contribution to volunteering in WA. He noted that volunteers are very important to the State and that he is enjoying the opportunity to meet with and thank volunteers in the community. Minister Dawson noted that it is a challenging time for volunteering, noting also that COVID-19 has added complexity in terms of the decline in volunteers, impacts of vaccination mandates etc.

Minister looks forward to working with VCRG and assisting volunteers to get back out into the community.

Other topics discussed:

#### 1. Volunteer screening in WA

The Minister noted advocacy to "Reduce the Burden" of volunteer screening in WA. He believes that the current fee for volunteers helps to ensure commitment to the process. There may be opportunities during the review of the NDIS legislation in 2025 to review fees and processes, and other opportunities to streamline Working with Children checks as part of a national review of

these processes across Australia. The Group reiterated the importance of changes in this area to the sector.

#### 2. Experience of Corporate Volunteering

The VCRG heard from Gemma Rapson, who is a member of the Corporate Volunteer Council and works for Woodside, which has a large, active corporate volunteering program.

Gemma provided an overview of the Corporate Volunteering Council which meets quarterly with members from Woodside, Rio Tinto, Deloitte, RAC, BankWest and Beyond Bank. There are a range of programs and approaches adopted in corporate volunteering including team based, skills based, pro bono, impact days and large scale environmental programs.

Western Australia is known as being a leader in this field nationally, although a number of programs are currently being paused, as part of their COVID-19 response. There is an enormous opportunity to grow corporate volunteering, including through virtual skills-based programs.

Employees who participate in corporate volunteering report higher levels of well-being, empathy and awareness of social issues.

The VCRG thanked Gemma for the overview and her significant contribution to the sector, over an extended period.

#### 3. Current state of volunteering in Western Australia

A presentation on the latest statistics and demographics for volunteering in Western Australia was provided to overview of the current state of the sector.

It highlighted areas of concern including the significant decline of formal volunteers over the last six years, the decline in the number of organisations volunteered for and the hours willingly given. There were some positive trends also noted such as the inclusivity of volunteering, the rate of participation in informal and virtual volunteering and increased motivation to use skills in volunteering roles.

#### 4. National approach to seeking more volunteers in Aged Care

The Commonwealth Department of Health is engaging all State / Territory peak volunteering bodies across Australia to recruit more volunteers for social companionship in Residential Aged Care Facilities.

Impacts of COVID-19 on paid employees and volunteer numbers has meant that residents have found themselves increasingly isolated. More announcements regarding the program will be made publicly soon.

### 5. Work and Development Permit Scheme

The Work and Development Permit Scheme in WA is administered by the Department of Justice and delivered in partnership with Aboriginal Legal Service WA and Legal Aid WA.

The scheme provides alternative pathways to expunge specified court fines for people experiencing difficulty paying due to hardship. One mode is through the provision of services to Volunteer Involving Organisations, who can register to be a sponsor. The uptake in WA has been very positive to date.

## 6. Development of Emergency Volunteering IT platform

The WA State Government has funded an upgrade to Volunteering WA's Emergency Volunteering platform. The upgrade will automate the process of volunteer registration and Volunteer Involving Organisations matching for spontaneous volunteers in emergency response and recovery. The existing site is still operational and new functionality is expected to be in place by September 2022.
